**Welcome and Introductions**

New attendees included Vice President for Diversity and Inclusion and a Big Ten Fellow.

**Guest Remarks**

Dr. Dodge shared her goal of studying the campus environment and the importance of retaining campus knowledge among departments. She also welcomed the collaborative effort of understanding Title IX compliance and its intersection with diversity and inclusion.

**General Updates**

The Chair reminded members to submit their preferences for 2020 SAPC meetings. In addition to plans for next year, a CARE staff member is leading a planning committee for the university-wide yearly event. A second call for volunteers were made and plans to proceed with planning will begin soon. CARE staff members also gave an update on the bystander intervention program Step UP! including the management of educators, number of students reached, and progress on a written report that will be shared with the SAPC.

SPH and OCRSM representatives gave an update on the upcoming Student Environment and Experiences Survey which is a campus wide, student climate survey that measures attitudes and beliefs about sexual misconduct. Few changes were made to the survey based on positive student feedback and the survey is scheduled to launch in February 2020. Members discussed strategies to reach pre-selected students to complete the survey such as Diamondback ads. Also, findings from previous analysis were shared such as who is more likely to intervene and why students decide not to intervene.

OCRSM and the Chair shared upcoming plans and meetings with the Senate. New Title IX changes were announced and discussed with members. Once new regulations are received, a final policy will go through the Senate for approval. The Chair plans to present at a Spring Senate meeting to provide an update on the SAPC's progress.

**Evaluation and Assessment Subcommittee**

The Chair has decided to place a hold on proceeding with incentives for completion of the Add Your Voice event portal while the budget is being determined. A CARE staff member provided a summary of CARE's recommendations for revisions to the programming checklist that was

shown to the SAPC over the summer. The Chair requested all members review the checklist and provide their feedback for revisions. Members discussed the purpose of the document and potential versions to create.

### **College Action Plan Subcommittee**

CARE staff member provided an update on the progress of CAPs. The subcommittee has received contact from a couple of schools regarding the development of their plan. Subcommittee members were encouraged to participate in consultations taking place next month.

### **Communication Strategy Subcommittee**

The Chair shared Raise Your Voice website analytics such as demographic data and how people are reaching the site. An autofill calendar for the website is in development as well as a budget for new campaign material. Members discussed outreach to local bars and their interest in trainings for their employees.

### **Departmental Updates and Announcements**

DFSL is currently interviewing for interns next semester and members were encouraged to inform students who may be interested. CARE's peer recruitment will start in the spring.
